Alejandro J. Valella, Vice President and Deputy Counsel of the Agencies, acted as Secretary and asked for motions and seconds to call the meetings to order of the Governance Committees of the New York State Housing Finance Agency (“HFA”), the State of New York Mortgage Agency (SONYMA), the New York State Affordable Housing Corporation (“AHC”), the State of New York Municipal Bond Bank Agency (“MBBA”) and the Tobacco Settlement Financing Corporation (“TSFC”).

Elaine McCann made a motion to call the AHC and HFA meetings to order; Committee Chairman Weiss seconded the motion. Elaine McCann a motion to call the SONYMA meeting to order; Mr. Lebowitz seconded the motion. Elaine McCann made a motion to call the MBBA meeting to order; Ms. Bayer seconded the motion. Elaine McCann made a motion to call the TSFC meeting to order; Ms. Bayer seconded the motion.

Mr. Valella noted that as items are presented to each Committee throughout the meetings, these motions and seconds will be used, unless specific items call for a different vote, or unless any Committee member wishes to record his or her vote differently.

The meetings of the Governance Committees were opened in joint session for the consideration of various matters of shared importance. These minutes reflect only those items being considered by the Members of the New York State Housing Finance Agency Governance Committee. A record of items considered by the other Agencies’ Governance Committees is contained in the minutes of each Committee respectively.

Mr. Valella noted that Elaine McCann and Ms. Watson were participating in the meeting by video conference from the New York State Division of Budget conference center at the Capital Building, Room 143, in Albany. A public notice was given of the time and locations of both venues.

The first item on the agenda was the approval of the minutes of the 27nd State of New York State Housing Finance Agency Governance Committee Members' meeting held on April 4th, 2012.

The next item on the agenda was a resolution authorizing the approval of the Amendment to the By-Laws granting authority to Governance Committee to approve and review procurement contracts that exceed one hundred thousand dollars. Committee Chairman Weiss stated that information regarding this item was contained in the materials provided in connection therewith, which materials are incorporated herein by reference. There was no discussion regarding this item.

Elaine McCann moved to adopt the resolution; Committee Chairman Weiss seconded the motion; and the following resolution was adopted unanimously:

Committee Chairman Weiss stated that information regarding this item was contained in the materials provided in connection therewith, which materials are incorporated herein by reference. There was no discussion regarding this item.

Elaine McCann moved to adopt the resolution; Committee Chairman Weiss seconded the motion; and the following resolution was adopted unanimously:


contained in the materials provided in connection therewith, which materials are incorporated herein by reference. There was no discussion regarding this item.
